AMH Oakdene (Red): Oakdene is a rehabilitation ward and during daytime hours the majority of clients are engaged in activities with occupational therapists and so this along with flexible working by the Band 6 who covers across the unit and a review of the acuity and dependency of patients ensured that patient/clients' needs were met safely. The ward is in the process of reducing its patient numbers in preparation for moving care into the community from October 2019.

Jubilee House (RED): During July when a focused piece of work was being undertaken on the unit the bed numbers were reduced by 50% and therefore the number of staff required to cover was also reduced but this is not reflected in the data. Therefore it appears that the unit was below plan for Registered Nurses (RNs) on both early and night shifts and for care staff on the early sifts. However the ward did have appropriate cover for the number of patients admitted and all care needs were met safely.

AMH The Limes (Amber): The area remained under plan for RNs in July on some day shifts and some night shifts due to vacancies and staff sickness. The ward was covered using a combination of existing ward staff, e.g. band 7 ward manager, bank and agency staff. This maintained patient safety and ensured all care needs were met.
