- Administrative and clinical staff who have the power to enter into contracts and/or agreements with other organisations on behalf of their organisation
- Administrative and clinical staff involved in decision making concerning the commissioning of services (i.e. where Solent subcontracts with other organisations), purchasing of goods, medicines, medical devices or equipment, and formulary decisions
