b. For each of those years what was the average waiting time (in weeks) for children who had an assessment for ADHD (Attention Deficit Hyperactivity Disorder).



d) What is your process for reviewing and deciding whether to accept or reject children who have been referred for an ADHD assessment.

The ADHD referral would be triaged by a CAMHS clinician and then the family contacted for a discussion based around the referral. The family and referred child/young person may also be invited into clinic for a screening assessment to ensure that there are no other mental health presentations alongside the ADHD query. Alongside, it is expected that school/social information is supplied alongside the initial referral and if it is not this will be requested by the CAMHS team to help inform the clinical discussions. It is always key to ensure that information is supplied/gathered which evidences the behaviour of the child/young person to underpin any ADHD query.

An holistic breath of evidence is always gathered to evidence decision making around whether to accept or reject a ADHD referral.

It is worth noting that if the service does not feel an ADHD assessment is indicated then this is discussed with the parent and consideration given for alternative sources of support should it be needed i.e., parenting, early help, counselling\*\*

e) Is your organisation confident that it is satisfying the NICE guidelines for children with ADHD?

The service reviews its offer against the NICE guidance on an annual basis to ascertain compliance against the guidance. This offers the assurance that it is compliant whilst also indicating areas for improvement/focusing upon to help improve compliance
